

A Message from the General Manager - Kevin Eason

Fall is slowly arriving in StillWaters. The daily temperature is slightly cooler and there is less humidity. The leaves on the trees are just starting to turn colors. In a few weeks StillWaters will be awash with the different colors of fall.

The SWRA office is still practicing COVID 19 guidelines for social distancing and face mask requirements. We understand this can be inconvenient for some property owners; however, we are following the guidelines to help protect office staff and property owners. The large number of owners who travel from other areas to visit StillWaters creates a higher risk of spreading the COVID 19 virus.

SWRA has closed the Welcome Centre and will no longer rent individual office space. Businesses that were located in the Welcome Centre have moved to other locations. The Welcome Centre building located adjacent to the Hwy 49 entrance has been leased to a new business that plans to open around the first of the year. Renovations to the building should start in mid-October. The new business has requested a formal announcement of their opening not be made until they are closer to their opening date.

It is that time of year when the SWRA Nominating Committee starts working on candidates for the Board of Directors 2021 election. Please read the article in this newsletter explaining how property owners governed by the '87 covenants and in good standing with SWRA can run for election to the SWRA Board of Directors.

There have been several requests by property owners to have another General Manager informational meeting. These meetings were very popular but were suspended due to COVID 19 restrictions. I will hold an open meeting in the SWRA community room located in the SWRA Centre on Tuesday, October 27th beginning at 5:30pm. The meeting will last about an hour. StillWaters property owners in good standing with the association are welcome to attend but reservations are required due to social distancing requirements. A conference call will also be available for property owners who would like to listen to the meeting. Please remember the gate attendants at the main entrance gate on Hwy 49 are very busy. Gate attendants are not allowed to give out addresses, phone numbers, or recommend restaurants. Packages or notes cannot be left at the entrance gate for attendants to distribute. The SWRA office offers package drop off, package pick up, fax, copies, notary service, and can answer all your questions about StillWaters. Please contact the SWRA office at 256-825-2990 or come by during operating hours if you need assistance.

Recently several vehicles have damaged the entrance side of Gate 34 (aka back gate). Anyone damaging Gate 34 must pay for the repairs and a minimum fine of \$300. The camera system at Gate 34 is able to video the driver of the vehicle, the vehicle license plate, provides a time stamped record of when an incident occurs, and the artificial intelligence even tells SWRA the type, make, and model of every vehicle that enters Gate 34. The cameras are filming 24/7 and since the new system was installed the first of the year, everyone that has damaged the gate has been discovered and fined.

The holidays are just around the corner. Plan on spending your holidays this year in StillWaters. It's the perfect place for family and friends to get together. Have a great fall season.



Advanced Disposal, the current garbage collection company for StillWaters, is being purchased by Waste Management. Several phone calls and emails to Waste Management by SWRA have gone unanswered. SWRA is continuing to contact Waste Management in hopes that a solution for better service can be achieved.

If you are interested in serving on the Board of Directors or know of someone who you think would be a good candidate, please submit their name to the committee for consideration. After the nominating committee reports to the Board, other names may be added to the ballot by petition. Property owners under the 1987 covenants not selected by the Nominating Committee may run for the Board of Directors by obtaining a petition signed by a minimum of 20 property owners in good standing with the Association. The election is for three seats. Each seat is elected for a three-year term. The new members will begin serving March 2020. The results of the vote will be announced at the Annual Membership Meeting. Remember, nominees must be property owners in good standing and under the 1987 covenants.

SWRA BYLAWS, ARTICLE VII NOMINATIONS AND ELECTION OF DIRECTORS

Section 7.1. The Board of Directors shall appoint a Nominations Committee of five (5) members, two (2)

of whom shall be Directors and three shall be non-Directors. The Committee shall be appointed at least

60 days before any members' meeting at which elections for the Board of Directors is to be held. The

Committee shall nominate candidates to fill Board vacancies at least 30 days prior to the election and

provide that list to the Secretary. No member of the Nominations Committee shall be eligible to be

nominated. Nominations of members, must be in good standing, may also be made by petition signed by

twenty (20) or more members, in good standing, filed with the Secretary at least thirty (30) days prior to the election.

WHO CAN RUN FOR A SEAT ON THE SWRA BOARD OF DIRECTORS?



This article has been published in the SWRA newsletter for the last couple of years. Please read the entire article if you are interested in becoming a SWRA board member.

There are four different sets of covenants in StillWaters and all property owners under these covenants are members of the association and vote in the board of director's annual election. However, only property owners who own property under the '87 covenants and are in good standing with the association are eligible to run for a seat on the StillWaters Residential Association Board of Directors. There are three seats on the board up for election. Each seat is elected for a three-year term beginning March 2020.

There are two different opportunities available for a property owner who qualifies and would like to run for the board of directors. One is to contact the Nominating Committee and inform them of your interest to run. The other opportunity is to run by petition. This information can be found in the Bylaws Article VII, Section 7.1. This article will discuss both opportunities.

RUN FOR BOARD BY NOMINATING COMMITTEE:

Each year a Nominating Committee is appointed by the SWRA Board of Directors to find qualified, willing board candidates to run for the board. The Nominating Committee works diligently each year to present qualified candidates to the association members. The Nominating Committee is charged to put forth who they have determined to be the best candidates to fill the board seats.

The Nominating Committee works several months contacting and interviewing possible candidates. The committee always requests that anyone interested in running for the board contact them so the committee can include them in their selection.

Any qualified property owner interested in running for election to the SWRA board can contact a member of the Nominating Committee and discuss what is required to be considered. The names of the committee members and their telephone numbers are included in this newsletter in the article titled SWRA *Nominating Committee Appointed*.

RUN FOR BOARD BY PETITION:

A qualified property owner may run by petition for the board. The person interested in running for the board must pick up a petition at the SWRA office. The potential candidate must obtain signatures from twenty separate property owners governed by the '87 covenants and in good standing with the association. As of the date of this newsletter, there are 1,451 properties governed by the '87 covenants so it should be very easy to obtain twenty signatures. The petition must be filed with the SWRA Board Secretary at least thirty days prior to the election.

It does not matter if a candidate is selected by the Nominating Committee or runs by petition. All candidates are treated the same. All candidates' information is published in the newsletter and all names are listed on the election ballot.

Being a SWRA Board Member is not easy. Each SWRA Board member attends a minimum of two board meetings per month on the first and third Tuesday of each month. There are additional special meetings, phone calls, and social events, such as new member welcome socials, all of which board members must attend. Board members discuss and make decisions that will not always be the most popular among all property owners but is the best decision for the community as a whole. Board decisions must also follow what is required in the governing documents.

Being a board member takes hard work and dedication. Each year I personally encourage several potential candidates to consider running for the board. Very few are willing to commit to the time and effort that will be required if they are elected. The Nominating Committee has the same issue. The committee contacts several potential candidates but few are willing to commit. If you are interested, make the commitment and run for an open board seat either by contacting the Nominating Committee or by petition.

AMENITIES ARE NOT FOR EVERYONE

StillWaters Residential Association is the master association for all residential properties located within StillWaters. All owners and their guests who have paid the required fees and are in good standing with SWRA may use the StillWaters amenities. These amenities are the Pineview pool, tennis/pickleball courts, Moonbrook park, fishing ponds, SWRA buildings, roads, gates, and other green space. There are fifteen sub-associations inside StillWaters. These sub-associations are mostly condominium complexes; however, some are single family house neighborhoods like The Hideaway and The Landing. These sub-associations have their own additional amenities such as walking paths, boardwalks, pools, beaches, gazebos, dumpsters, parking lots, and green space.



Their amenities can only be used by those who own a condo or house in the sub-association and pay the extra fees required by the sub-association.
