Notice

The StillWaters Architectural Committee (ARC) approves building permits in accordance with the StillWaters 1987 Covenants and Exhibit "B" of the Covenants. In addition to SWRA ARC approval your permit may need Alabama Power and/or Tallapoosa County Building Department approval. The ARC **does not** approve or inspect for compliance with Southern Building Codes, Tallapoosa County Building Codes, or Alabama Power requirements.

- **Failure to obtain required permits from Alabama Power or Tallapoosa County may result in fines and/or the removal of any unapproved structures.**
- **The StillWaters Residential Association nor the Architectural Committee can be held responsible for your negligence in obtaining required permits and following State and/or County regulations.**

If your permit request requires Alabama Power approval, Alabama Power will not approve it until they receive a letter from SWRA that the ARC has approved the permit.

If your permit request requires a Tallapoosa County building permit in addition to the SWRA permit it is your responsibility to contact Tallapoosa County **Building Department** located in the **Tallapoosa County** Courthouse, at 125 N Broadnax Street, Dadeville, Alabama, Room 12. <https://tallaco.com/content.asp?formid=1504&id=80527>

Submitting your building application.

The Architectural Committee (ARC) meets the 1st and 3rd Wednesday of each month. Owners requesting a building permit must be in "Good Standing" with the Association (no outstanding fees or fines) for building permit requests to be considered. All requests for building permits and the required documentation must be received no later than the close of business on the day preceding the next meeting date to be considered at that meeting. Applications received after the deadline will be considered at the following meeting.

I have read the above notice and understand it is my responsibility to contact either or Alabama Power or Tallapoosa County to ensure I am in compliance with their requirements.
