Hello friends and neighbors! We hope everyone had a lovely Thanksgiving. Can you believe December is already here? The community is buzzing with holiday spirit as we wrap up 2025! StillWaters is absolutely glowing with festive decorations this year. We hope you enjoy them as much as we do! We are fortunate to be moving forward on many projects and planning for 2026. Our new Community Association Manager (CAM) Jason Klepper has jumped right in as he is familiarizing himself with StillWaters. The multiple covenants are challenging, it is the time for year-end reporting, new contracts and the budgeting process for 2026 is in full swing. Thankfully, Jason is experienced and calm, so he is taking it all in stride as the staff and seven board members work with him to move forward in the many areas and issues for SWRA. It's a lot to take in and he is handling it all beautifully! We're so happy to have him on board!

We want to provide a quick, transparent update regarding our 2026 annual dues. To keep pace with the *Cost-of-Living Adjustment* (COLA) (2.8%) and continue offering the wonderful service levels our residents deserve, the Board approved a slight annual dues increase of just \$14 for the year. To help maintain and preserve our shared amenities and community assets, a one-time annual 2025 assessment of \$100 was also approved. This means the total annual fee for each home/condo/lot will be \$612. This fee is due on January 1, 2025, and we kindly ask that payments be made no later than January 31, 2025. Annual gate easy entry fee will also be billed at this time.

Owners will continue to have the opportunity to make a voluntary contribution to help support our Community Services Patrol. We're so pleased this service has been appreciated by many neighbors and continues to be a positive addition to StillWaters! A special shoutout and our **heartfelt thanks** to Mike 'Finch' Fincher. We are so grateful for every single SWRA staff member. Their caring, concern, and diligence are what make StillWaters such a wonderful place to call home. Keeping our community running smoothly takes immense effort, so please join us in expressing your thanks to them **for a job incredibly well done** when you see them around!

## Important Reminder

### Important Reminder Regarding Golf Cart, ATV, and UTV use in StillWaters

The StillWaters Residential Association (SWRA) has recently received several reports of Golf carts, ATVs, and UTVs being operated on privately owned vacant property, SWRA-owned property, Alabama Power Line property and areas belonging to the Stillwater's Golf Course. We want to remind all residents that the use of these vehicles on property you do not own or have explicit permission to enter is considered trespassing.

Please also note that all **Golf Carts, ATVs, and UTVs operated within StillWaters must meet SWRA safety inspection criteria and must display a current-year SWRA vehicle decal.** Vehicles that do not meet these requirements are not authorized for use within the community.

Additionally, **all such vehicles must be operated only by licensed and insured drivers as required under Alabama law,** and all operators must adhere to the rules and regulations outlined in the **SWRA Motorized Utility Vehicles Policy.**

To ensure safety and respect for all property owners, Golf Carts, ATVs, and UTVs may be operated **only on approved SWRA paved roadways** and must always be used in a careful, responsible manner. **Off-road use or driving through private lots, common areas, Alabama Power Line property, or golf course property is not permitted.**

Please be aware that **owners may be held financially responsible for any damage caused** to property not in their ownership.

We appreciate your cooperation in helping maintain a safe, responsible, and respectful environment for all who live and work in StillWaters.

## 2026 Golf Cart Registration

### 2026 Golf Cart & ATV Decals

As we move into the new year, all golf carts and ATVs within StillWaters are required to display the new 2026 decal. The 2026 golf cart and ATV decals will be available **January 5, 2026**, at the StillWaters office.

#### If You Previously Registered

If you previously registered your golf cart/ATV and signed the Waiver of Liability, you do not have to bring your golf cart/ATV to the office to receive your new 2026 decal.

#### If You Have Not Registered

If you did not register your golf cart/ATV previously or if you have a different golf cart/ATV than the one you previously registered, you must bring the golf cart/ATV to the office to have it inspected and registered to receive your new 2026 decal.

#### Vehicle Requirements to be Registered

- Operating headlights
- Operating Brake lights.
- Operating Taillights
- Rear-view mirror

## Winter Preparedness

### Winter Preparedness Tips for StillWaters Residents

Winter is right around the corner! Take time now to prepare your home and property for freezing temperatures. Whether you live here year-round or visit seasonally, these steps will help protect your pipes, prevent damage, and keep you safe all season long.

#### 1. Safeguard Your Outside Faucets

Disconnect and drain all garden hoses before freezing weather arrives. Water trapped inside can freeze and burst pipes. During extremely cold spells, use **insulated faucet covers** for extra protection.

#### 2. Wrap Exposed Pipes

Pipes in unheated areas—like attics, crawl spaces, and exterior walls—need insulation. Use **pipe sleeves or insulation wrap** to retain warmth. If possible, **drain unused water lines** to prevent freezing and bursting.

#### 3. Set Thermostat to No Less Than 55°F

If you'll be away for an extended time, set your thermostat to **heat** and no lower than **55°F**. This prevents frozen pipes and costly water damage while you're gone.

#### 4. Reverse Ceiling Fan Direction

Switch ceiling fans to **clockwise rotation** in winter. This pushes warm air downward, improving comfort and energy efficiency.

#### 5. Prepare Your Fireplace

Have your fireplace **inspected and cleaned** before use. Keep **flammable materials at least 3 feet away**, and when it's not in use, **close the dampert** to keep warm air inside. For gas fireplaces, **top off your propane tank** before the cold sets in.

#### 6. Valve Out Water Before Leaving

If you're leaving your condo for an extended period, **shut off the main water supply** at the isolation valve and **turn off the breaker** to your hot water heater. A closed valve handle should be **perpendicular to the water pipe**. This simple step can prevent leaks that might damage your condo—and your neighbors'.

#### 7. Prepare for Power Outages

Winter storms can cause power outages. Keep these essentials ready:

- Flashlights & extra batteries
- Portable phone chargers
- Battery-powered radio
- Blankets & warm clothing
- Candles, matches, and a lighter

#### Stay Safe & Stay Prepared

A few precautions now can save time, money, and stress later. Let's keep StillWaters warm, safe, and ready for whatever winter brings!
